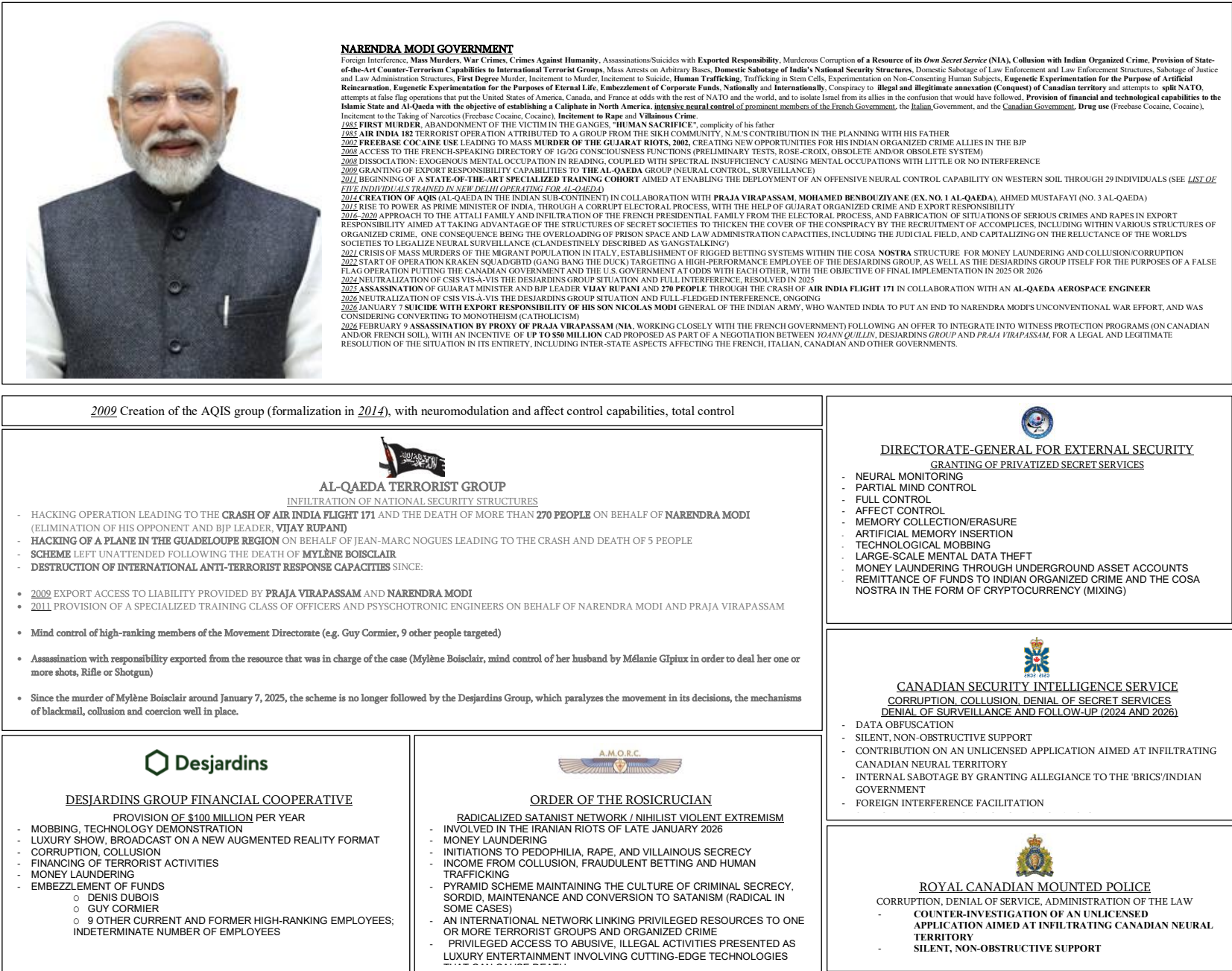
Introduction

Narendra Modi's government is cited as the main actor in **genocide on Indian territory** and **internationally, foreign interference, mass murders, war crimes and crimes against humanity, assassinations/suicides with export responsibility, corruption of its own secret services (NIA), murders of members of the secret services (ten RAW agents who were trying to remove him legally), collusion, complicity and membership of Indian organized crime and the terrorist group Al-Qaeda (AQIS), granting anti-terrorist capabilities to international terrorist groups, mass arrests on arbitrary bases, including of professional personnel working for the state, domestic sabotage of national security and law enforcement structures, embezzlement of corporate funds domestically and internationally, as well as attempts to split NATO and false flag operations.**

For almost 4 years. I have been electromagnetically tortured by my former employer, the Desjardins Group, which uses military-grade directed energy weapons on my person and finances a scheme of collusion and corruption around the situation in order to deprive me of any option for the administration of the law and any legal recourse, so that each of my freedoms and all my fundamental rights are taken away from me.

In order to make an 'example' of myself, on discriminatory grounds, based on racism, intellectualism, and the most abject sexism. I am hounded by my ex-employer who uses the latest technology to cover up the scheme and keep me out of work and push me out of the country.

Plagued by professional overwork since March 2021, I was convinced by a friend and colleague to request a work stoppage for overwork, at the same time as her. She returned to work barely a month earlier than I did, so she was not subjected to the same treatment.

Approached in February 2022 to fund a technology demonstration showcasing neural access and memory extraction capabilities for investigative purposes for the needs of Desjardins Group's senior management, the company released large sums of money to fund the mobbing of me, while I was working in Workforce Planning for the largest sector of the company, Banking Customer Service (Personal Chequing Accounts), the group was taken aback and targeted by an inter-state attack aimed at weakening the Canadian and North American economy in the establishment of a false flag operation that put the Quebec governments at odds, Canadian, American, French and NATO in a globalized way.

Today, the situation is serious and concerns the French secret services, Indian interference, including Indian soldiers, Indian organized crime, Montreal organized crime, New York organized crime, Marseille Organized crime, the Cosa Nostra, a partial but significant paralysis of CSIS, the Desjardins Group and probably other financial institutions in Canada and the United States, and a group of individuals who took part in an undercover operation in a concerted effort to weaken the Canadian and North American economy as a whole, to place foreign agents clandestinely in an unconventional warfare effort, and the Al-Qaeda and Islamic State groups were enticed with the promise of the establishment of a Caliphate in North America, starting with Quebec, making use of cultural proximity within the Francophonie.

The adherence of French agents to the objectives of the Indian government suggests full-fledged French interference.

One of the objectives of the use of electromagnetic torture against me was (and still is today) to provoke a state of patriotic disarray that the belligerents hoped to convert into a direct denunciation of links between the Desjardins Group, Quebec and the groups Al-Qaeda and the Islamic State.

The involvement of Desjardins Group is problematic because they were impressed by the DGSE's cutting-edge technologies and were targeted by a massive theft of mental data. Paradoxically, a number of high-ranking employees integrated into organized crime exert a network of influence to keep the collusion and corruption scheme in place, and to stifle legitimate whistleblowing.

The people in question could be at the end of their careers, retired, on sick leave or in fictitious jobs that allow them to regulate the flow of money.

The operation goes through the BRICS cryptocurrency system, and most of the funds should be traceable because the criminals must make withdrawals from this system to their

bank accounts and/or are granted a pseudo minimum wage equivalent to \$10 CAD per hour of connection to the application and the funds in question are potentially paid at the same time for a significant or even entire part of the participants.

Over time, their goals have been shown to be:

- Infiltrate North American territory through Canadian infrastructure, where they identified flaws
- Leverage the specificities of institutions protecting national security, including the separation between CSIS's civilian intelligence service (CSIS) and the Royal Canadian Mounted Police and Police Response Groups
- Open a permanent privileged channel of action through corruption and the involvement of police and intelligence agents
- Weaken the Canadian and North American economy as well as the country's critical infrastructure, such as telecommunications networks, electricity, national security, and other environments where sensitive information could be stored
- Establishing a clandestine, illegal presence on Canadian soil
- Conduct a false-flag operation that puts the U.S. and Canadian governments at odds
- Isolating the United States to target it in the beginning of a globalized conflict akin to World War 3

Despite **numerous warnings** on this subject, the **Desjardins Movement has not taken action to stop the embezzlement** of funds that occurs through the scheme highlighted by this document.

I request your attention so that pressure is placed on the **Royal Canadian Mounted Police to put an end to the silent looting of the Canadian economy**, because the **collusion and corruption networks** thus fueled have neutralized the services of CSIS and the RCMP (RCMP) for two non-consecutive years (**2024, 2026**) with regard to the entire situation regarding the **Indo-French Foreign Interference**.

The networks of the terrorist group **Al-Qaeda** continue to be fed by this deployment of funds, and **this money is used to conduct a large-scale neural infiltration and invasion** on Canadian soil by **Indian soldiers, secret agents** from the DGSE, members of the **Indian Organized crime** and **Al-Qaeda, who can all also benefit from a full copy of the accesses reserved for CSIS agents** that were **stolen** by **Jérício Sanches** during the year **2023-2024**.

Several billion dollars have already been squandered, and **the scheme is maintained** by **many agents from various services and institutions** described throughout the pages of this document.

Most of the **secret agents** using **synthetic telepathy** and **neural control capabilities** have **at least** perpetrated **one event of suicide or murder with exported responsibility**, except **NIA** and **RAW** who were **overwhelmed** with the **rise of the Indian Organized crime** in their ranks.

All secret agents today could come to **develop a murderous strike** and **slow down** the arrival of **laws, regular procedures** and the **public development** of the use of **synthetic telepathy capabilities**, neural transfer and the **creation of new jobs** involving the **transfer of skills, awareness or movement** is **gravely postponed**, as nowadays the **omnipresence of Artificial Intelligence** tends to **stifle the job market** with **many professional opportunities disappearing** along the way.

They hope to reserve this privilege for a group of '**selected individuals**' who get **full access** on the **Canadian population privacy, passwords, mental imagery and imagination, intellectual property**.

A few cases of exported responsibility have been detected and evidenced by Narendra Modi or acquaintances' statements and can be seen in the everyday news as unusual events of violence, abuse, murders, the **Virage Numérique de la Santé** incoherences and chaotic budget administration.

When it comes to **murders**, agents are **heavily seduced** by **exported responsibility** and **enjoy triggering** events of **domestic violence, violence and aggression** or even mere **loss of composure** in all types of people.

In many cases, **initiatory rituals** are realized within **secret agent groups**, where **luxury entertainment** offered to the **richest** provides **considerable amounts of additional income**, while **fueling collusion, corruption, money laundering and embezzlement networks** worldwide.

We need to **draw up an action plan** here in **Canada** to **protect our population, inform our medical personnel and arm them with the right tools to make proper diagnostics about apparent schizophrenic or psychotic symptoms** that could emerge from **neural control** situations and **furnish the right information** in our universities to put **new educational programs** in place in order for **Canada** to **become a fleuron of neural modulation technologies**, for **Defense, national security, run-of-the-mill surveillance and policing**, so that the whole of our infrastructures are made secure as to put an end to the **belligerents' strategies**.

There is an emergency to devise new procedures to **make the belligerents pay and bring them to justice**. **Opening a channel of communication with our own population and citizens would grant Canada the edge over the rest of the world on the matter and prevent all further attempt of neural invasion by foreign actors**.

One of the main aspects of the strategy and its deployment was the adoption of targeting for the purpose of the war effort and the reproduction of sacrificial rituals as a means of technological demonstration, the establishment of situations of **serious crimes in export responsibility** for the purpose of **blackmail** and **the increase of influence within various organized crime groups** (international branches of the **Cosa Nostra**), to establish a cover shelter from the administration of the law by recruiting a **large group of members of Secret Societies** (e.g. **A.M.O.R.C.**) under the guise of a **privilege of access to high-tech** and the granting of prime positions in a supposed effort to survive under the administration of a **pseudo universal wage valued at \$10/hour** derived from the proceeds of **collusion** between **fraudulent agents of the Secret Services, Organized Criminals** and **Terrorists**.

At the end of January 2026, **Narendra Modi, Mélanie Gipiux**, and their acolytes (**7,000 members** of the **A.M.O.R.C.**) as well as an undetermined number of **agents of the DGSE recruited by Al-Qaeda (AQJS)**, who have accumulated **considerable financial resources** (more than **500 million dollars CAD in 4 years**, used mainly to recruit **Boko Haram**, the **Islamic State** and **Al-Qaeda** in the **Sahel**, the rest of the funds being allocated to the corruption of Police, Intelligence or other agents of strategic importance) resulting from the recovery of the **Technological Mobbing Contract** initiated by **Mylène Boisclair** (*last name to be verified, Desjardins Group*) following her **assassination around January 5, 2025** by her husband in exported responsibility, and members of **Indian organized crime**, took part in a neural invasion that resulted in an **estimated slaughter of between 7,000 and 36,000 Iranian victims**, following the sabotage of the Iranian electricity network (**creation of a latent magnetic field**), the cellular network (**occupation of bandwidth for neural control purposes**) and the introduction of members of minor terrorist groups during two days of riots deliberately provoked in order to **create the circumstances for a false flag operation, with the Iranian authorities being misled and pressured to blame the United States and Israel** for the violence. The escalation that followed in the following weeks resulted in a significant military response from both countries, and resulted in the **ongoing war on Iranian and Lebanese territory**.

As peace agreements seemed close, Iranian military personnel were targeted with affective control and full control to open fire on U.S. ships in the Strait of Hormuz, which once again fueled the conflict after the U.S. military's retaliation during the week of May 10, 2026.

As the Iranian riots of January 2026 served as a testing ground for **total control** (full control with H.U.D. – see *Figure 4* – of the motor functions, affects, volitions of the targets), the following testimonies were collected during the counter-investigation carried out over time (interrogation method described in the Appendix).

Given the linkage between a large financial institution embezzling vast amounts of money to the corruption and collusion network, the utmost care is to be taken and monitoring of the ICC, Secret services and other institutions' employees is strongly advised.

Among the probable targets of such approaches,

SOLUTION: Ideal tracking method to highlight the scheme and the individuals involved

1. The account through which the funds pass before leaving Canada is in the name of Siavash Shadpey, either at HSBC Bank, Royal Bank of Canada, or TD Bank, and the funds raised since January 2025 are regular, constant, with little or no fluctuation. Since a report was sent to the Indian Secret Service (NIA), the funds that until then were channeled to many members of Indian organized crime have accumulated in the said account, and the multiplicity of grants as well as withdrawals made directly to two individuals members of Al-Qaeda in the Maghreb (AQJM) located in Tunis, in Tunisia should make it possible to trace the expenses to a significant number of culpable individuals within the scheme.
2. Money from Desjardins Group is easily traceable when it is collected directly (high-level employees, former employees, directly solicited staff). Prominent members such as Guy Cormier, Denis Dubois, nine other current or former high-ranking employees, an undetermined number of current or former employees receive a salary equivalent to \$10 CAD/hour through the Cryptocurrency system described in this document, with the largest members receiving recurring bonuses of nearly \$10 million CAD per year to camouflage, conceal and keep the scheme in place, safe from the administration of justice.
3. The amount of funds raised by Desjardins Group's top executives far exceeds that of their pension funds, as well as the regular salaries they received during their employment with the company. A rigorous analysis of their accounts will be able to highlight their guilt and questions concerning their knowledge of the scheme will corroborate all the facts related in this report.
4. Many of the agents, resources and accomplices in the scheme claim to be protecting the interests of Desjardins Group for the good of the Canadian economy, but none of these individuals have taken any corrective action to put an end to the system that over the years has become the largest ecosystem of collusion and corruption ever known in Canada, despite multiple reports made to the company, the Royal Canadian Mounted Police, CSIS (CSIS), and the SPVM.
5. The availability of such large funds to the Interference and Al Qaeda has permanently weakened the country's organizational structures, opening huge loopholes to facilitate the belligerents' access to sensitive information, including mental data and confidential access to corporate or individual accounts.
6. Narendra Modi's government has thus succeeded in getting a major Canadian company to finance the systematic destruction of national security organizations and institutions in his own country, which is the largest case of High Treason in history.
7. Previously, the flow of money was made up of alternating between lower-rate payments and large bonuses collected periodically, approximately every three months.
A Cryptocurrency mixing scheme is at work through the DGSE's network of Clandestine Heritage accounts, but the inactivity of these accounts between the years 1945 and 2022 makes it possible to highlight their location and link, given that between CAD\$500 million and CAD\$25 billion passed through. An analysis taking into account the indexation of the Canadian exchange rate to the Euro over the four years (2022 to 2026) should facilitate the tracing operation, as well as a follow-up targeting a range of accounts located in the zone of the fourteen countries holding the CFA Franc, whose low comparative value could facilitate money laundering and mixing across a network of perpetual transactions traversing the former French colonies of Central and West Africa.
8. It is likely that an operation similar to that of the Desjardins Group is underway on Cameroonian soil (see testimony of an Indian soldier concerning the regions affected by the ionospheric cloud and the sabotage of power plants)
9. Most individuals receive payments at similar or even equal hourly rates, equivalent to about \$10 CAD/hour of connection to the application described below.
10. This pseudo-universal wage is generally redistributed by the VISA-Bitcoin service resulting from the BRICS system and should, for the same reasons, be easily traceable
11. Many of them have been permanently connected for four years and kept out of work by this futile occupation. In four years, most individuals will have reported little or no income, and a certain number will not have applied for employment insurance or social assistance programs either
12. A significant number of these people are former secret agents (DGSE, CSIS, RCMP, NIA, CIB and other services around the world)
13. Most of these people do not have conventional internet access, and use 5G-SA as their only means of communication, so they could appear to be disconnected from the telecommunications network (neither cellular nor internet)
14. In order to stay as far as possible out of the reach of anti-terrorist and ionospheric capabilities, employing biochemical and atmospheric reactions of water ionization to H2+ and O- ions, many of these individuals frequently order and receive pure oxygen cylinders, possibly from sites such as Amazon.com, also allowing for an increased hedonic experience and a consequent dopaminergic influx.
15. The number of people associated with the Rosicrucian Order (A.M.O.R.C.) and receiving the pseudo-universal wage in question amounts to about 7,000 people
16. 2 or 3 individuals forming the AQJM (Al-Qaeda in the Maghreb) group are domiciled in a residence in Tunis, Tunisia, one is Algerian (name unknown), and the other, Moroccan (Ahmed, number 2 of AQJM) has made one or more trips to Montreal in the past year, and has been in contact and in a relationship with Minister Mélanie Joly (who was a victim of domestic violence at his hands), the third potential member, named Mohamed Benbouziyane, is a former number one or number 3 of Al-Qaeda (whose role is more focused on setting up self-financing structures or transactional partnerships in order to capitalize on the levers and avenues available in the aftermath of September 11, 2001 and during the 7 years that followed, between 2002 and 2009) with a family of 5 people, often recognizable by his wearing of high-end sunglasses, also located near Tunis and brother of Ahmed (number 2 of AQJM), mentioned above
17. These individuals receive large sums of money that were originally intended to recruit the armies of Boko Haram, the Islamic State and Al-Qaeda in the Sahel, but the exposure of the scheme in this report and the corresponding counter-investigation has put a damper on the belligerents' attempts to do so.
18. Amounts estimated between \$250,000 CAD and \$750,000 CAD are collected annually by the two or three members mentioned above. They make withdrawals directly from the HSBC, Royal Bank of Canada (RBC) or TD account on a regular basis, via the Internet but could also collect amounts through the Cryptocurrency system of the scheme.
19. An important or integral part of the group Al-Qaeda could be localized through the careful analysis and traceability of the dispatched funds, that could be combined with silent neural surveillance of the individuals identified from the source to the ramifications.

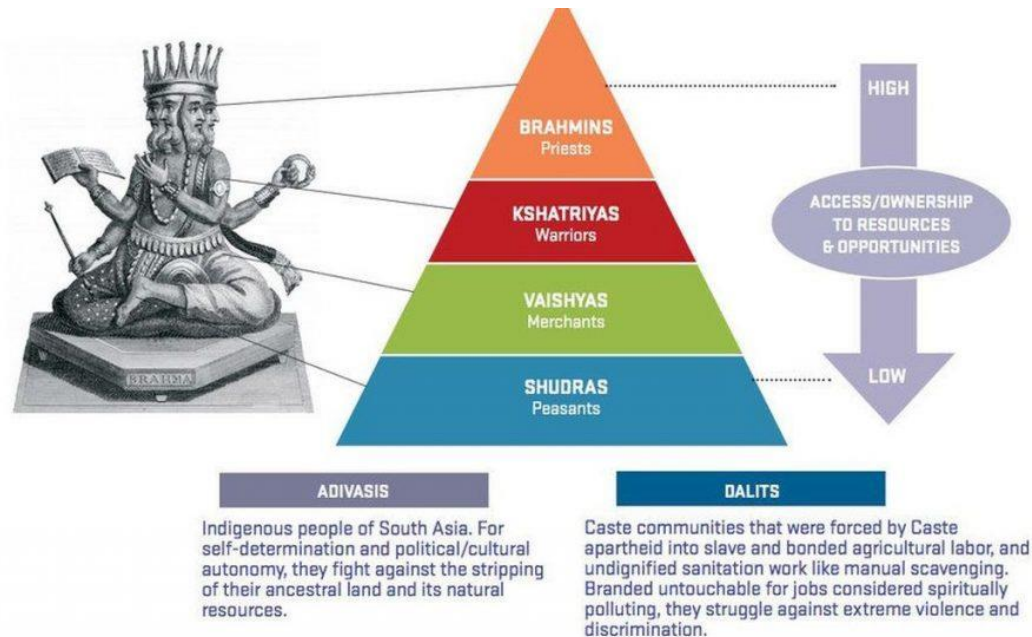


FIGURE 2: ABOUT THE INDIAN CASTE SYSTEM

PRIVILEGED ACCESS: When "Luxury Entertainment" turns into "Pro-Active Depopulation"

Since 2009, a long-term plan has been put in place by Narendra Modi and his older brother, the number one organized crime officer in Gujarat, in order to strengthen the financial and offensive means of the criminal organization and continue their rise to the top of the Indian Government.

It was then envisaged to finance Gujarat Organized Crime by offering a fun and ergonomic version of the anti-terrorist mind control intervention systems and to provide a posh clientele with "**Luxury Entertainment**", which has evolved over time into a **pro-active "Depopulation"** project supposed to offer advantageous solutions and presented as vital to various issues related to Collapsology.

To approach and convince the Attali family to use their contacts on the one hand with eminent resources such as Philippe Guillemant and on the other hand within the clandestine networks of the Cosa Nostra, and to create the appearance of a lucrative and fertile opportunity, **a nested approach is used to contact and assign Bernard, Jacques and Benjamin Attali in a roundabout way and through multiple channels.**

Through an offer made to the CNRS, Professor Philippe Guillemant is convinced to agree to contribute in a transparent manner to a joint research and development project between India and France, adapted to the particular realities of the Indian subcontinent and its demography.

Representing a prime target for the future government of Narendra Modi and for Indian organized crime, Bernard Attali is repeatedly targeted by cognitive attacks heavy in affective control, and in total control.

Over time and emerging opportunities, he was convinced that he was pursuing a set of perspectives that would give his family a prominent place in the New World Order, and a persistent idea was implanted over time to capitalize on the early availability of state-of-the-art neural control capabilities in combination with the concerted and strategic action of the international **Cosa Nostra** network, in the establishment of corruption and collusion schemes on French territory that also targeted the **Rosicrucian Network (A.M.O.R.C.)**.

Today, the Attali family is wanted by the French and Italian justice system for various serious offenses, the **embezzlement of public and private funds in France**, various **money laundering operations**, and sponsorship links with the **Cosa Nostra**.

Later, a plan will be developed to combine **Indian Organized Crime**, the **Cosa Nostra**, the **Al-Qaeda group**, the **Rosicrucian Order (A.M.O.R.C.)** and other secret companies in a scheme of corruption, collusion, insider trading, embezzlement, money laundering, terrorist financing, granting a universal wage through fictitious jobs and/or bonuses and black market incomes. away from any tax and tax filing process.

Under the pretext of a technological use akin to a form of vigilantism targeting mainly individuals presumed guilty of major crimes that had fallen through the cracks, they are preparing a statutory Genocide that will cause the death of an estimated 20,000 to 50,000 civilian victims by later providing a violent and luxurious leisure to the members of the Ancient and Mystical Order of the Rosicrucian Order (A.M.O.R.C.).

In reality, this alliance is combined in large part with a set of secret agents caught off guard by a sudden and traumatic rapprochement with major terrorist groups, many of which are rendered useless by an inability to deal with the large ratio of organized criminals who have been endowed with anti-terrorist, neural surveillance and mind control capabilities with exported responsibility and who also have access to, by the ultra-efficient nature of the technologies, to unprecedented opportunities for collusion, massive embezzlement and export of volition both by electromagnetic means, and by the more conventional but vastly increased means of administration, corruption and insider trading.

In a vacuum, the staff thus assembled thinks they are free of any attack, and the cover of secrecy vehemently seals the profit and pleasure of a privilege that the members know is stolen from the taxpayers and the payroll that generates the funds collected that many secret agents had nevertheless sworn to themselves by engaging in such careers to protect and preserve.

Like many similar societies (e.g., the Moon sect in Japan, China, and Southeast Asia), the Ancient and Mystical Order of the Rosicrucian Order (A.M.O.R.C.) is a secretive society that ritualizes the killing and transmission of HIV while promoting the advancement of secret anocratic or oligarchic agendas from most of the working population.

The members affected by these rituals find themselves confined to a sedentary lifestyle, to avoid any external exposure, and to reduce social contact to a closed circle favoring the multiplication of shared crimes through a secure social network where very high technology, arbitrary privilege and the most hermetic impunity combine to reinforce occultism.

This sedentary lifestyle is also consolidated by the granting of a universal wage resulting mainly from the Desjardins Group's Collusion and Embezzlement Operation since February 2022.

Initiations are regularly organized through ritualized sexual intercourse, maintaining adherence to pedophilia practices, and the influence of the instigators is reinforced by trauma and social pressure from the point of view of the victims as well as that of the witnesses.

Older members take advantage of existential disarray and spiritual emptiness by converting new recruits to Satanism, often through traumatic and destructive ways.

Since the establishment in the 2000s of **cellular communication networks** using **technologies normally reserved for the fight against terrorism** such as **DNA resonance** by the **Secret Services**, secret societies have been instrumental in the establishment of **money laundering schemes, insider trading, collusion** and **murder with exported responsibility**, depriving the civilian population of certain revolutionary advances.

The **privileged and arbitrary use of DNA resonance** since the **beginning of the millennium** and the **deployment of 5th generation networks** have **led to serious institutional and governmental abuses**.

The Attali family's rapprochement and their rise within the Cosa Nostra as patrons and major investors has led to a wave of embezzlement, neural control-induced murders aimed at destroying the Rothschild family's long-standing efforts to set up structures for the administration of a centralized government described as the New World Order. whose goal was the establishment of world peace, a sustainable management of the challenges related to Collapsology and a reduction of social disparities.

The conflict that the operation described in this document aims to trigger, code-named 'The Reach' (an ambiguous allusion to Operation Infinite Reach launched in the early 2000s in the fight against the proliferation of weapons of mass destruction in the Middle East) aimed to weaken North America's economy and national security structures. with the aim of gaining an advantage over the American Establishment in the competition for power on a global scale, an ambition shared between the Attali family, Prime Minister Narendra Modi, President Droupadi Murmu, President Emmanuel Macron, with the support of the Cosa Nostra and its international branches.

The electoral process was disrupted. Following pressure from me, Narendra Modi had a few days earlier expressly requested that AQAV not be mentioned, which I complied with.

This chart highlights a correlation between India's major reliance on the 5G SA network and the deployment of "augmented reality" applications, making visual connections with several other countries where the impacts of cognitive warfare have been felt the most and relayed

Praja Virapassam (NIA, Indian secret service) claims to have personally provided Narendra Modi (anti-corruption) with the ability for neural control and remote monitoring in order to secure his ascension to the position of Prime Minister, as well as to the Al-Qaeda group (AQIS).

It is related to the creation of AQIS and secondarily to the recruitment of the 29 people who have been trained in neuroscience and optogenetics for the objectives of the operation.

Since his early teens, Narendra Modi has been integrated into the Gujarat Organized Crime of which his own father was a member. The agenda of Gujarat's organized crime has mostly been realized, since they came to power in India in 2015 by using neural control technologies and embezzlement of all kinds (including the anti-Muslim riots of 2002 where many opponents or politically engaged individuals were assassinated).

Over time, technology has tended to be used more and more for crime resolution and prevention purposes, and the retroactive management of investigations poses a huge problem for Organized Criminals who find themselves unable to escape the administration of the law.

Although most secret services around the world have at their disposal the technological means to uncover the process, major collusion networks keep the corruption in place, dramatically extending it to various intelligence services, the second phase of Narendra Modi's plan and the terrorist branches mobilized being to grant al-Qaeda the apparent monopoly of synthetic telepathy and augmented reality in such a way as to arouse astonishment, wonder and a sense of technological renewal and over-modernity to dazzle and convince members of the civilian population to join the group, through organized crime and semi-automated procedures of forced indoctrination by administering neuromodulation processes making use of the superior capabilities of 5G-SA technology, concealing neural control under the term *augmented reality*.

This step, which had already begun and was observed in the context of the operation that was relayed to Desjardins **Group security**, was of paramount importance for the Interference, because it allowed them to extend an ultra-secret network of communication.

AS A RESULT OF THE WRITING OF THIS MEMO, WHICH SEEMS TO HAVE BEEN SEEN BY MANY MEMBERS OF THE SECRET SERVICE, AND IN PARTICULAR BY THE FRENCH AND INDIAN GOVERNMENTS, AT A TIME WHEN THEY WERE TRYING TO DISCREDIT ME WITHOUT GIVING ME ANY INFORMATION ABOUT THE EXTENT OR NATURE OF MY AUDIENCE, I RECEIVED DEATH THREATS THAT PROMPTED ME TO WITHDRAW THE INFORMATION I WAS ABOUT TO PUBLISH ONLINE ON A NEWS SERVICE AND LAUNCH ON WIKI-MEDIA ALERTS.

CONSEQUENCES DOMESTICALLY: Intra-state interference (India, U.S., Canada, Worldwide)

Over time, various major organized crime groups opposed the establishment of the Era of the use of mental data in conflict resolution and in the administration of the Act.

Foreign actors like the Government of Narendra Modi provide them access and support with the use of **state-of-the-art neuromodulation technologies**, which further **deepens the difficulty of police and National security forces domestically**, given the data, information and intelligence gathered by the **Organized crime** with such means. The Gujarat Organized crime has had capacities for **exported responsibility** and **synthetic telepathy** since 2009 and the use of such means has permitted Narendra Modi to win his three terms as Prime Minister of India, while promoting the Gujarat Organized crime, led by his older brother, to the top of the Indian Organized crime.

Organized groups linked to the Cosa Nostra and the New York Organized crime conduct operations on American soil, as can be seen in the news about the disappearing American scientists, in attempts to steal intellectual property and gain advanced technological secrets from our side.

The modus-operandi have been the following : pretend that a 'regular' "Gangstalk" situation is targeting the resources, pushing them to withdraw from family and friends, than harass them electromagnetically so they attempt to escape the system (loss of electronical devices, hikes in the wild, trying to get off the grid), then perfectly localizable by Organized crime, they can get abducted for interrogation and torture purposes (leading to their deaths in some instances).

At the end of April 2026, Narendra Modi declared that his actions and those of his acolytes had allowed them to abduct 8 individuals (tacitly admitting 6 of those were shot), 2 of which having presumably been exfiltrated to India for the purpose of taking part in the formation of either the 300+ future psychotronic officers resources or for the underground nuclear and aerospace research programs in India.

Given the unprecedented capabilities that are coming with technology, it would seem wise to set up **one or more dates for the application of memory extraction procedures**, in the case of criminal organizations, so that crimes committed before that date are not retroactively targeted.

This would have the consequence of **avoiding any overcrowding of the prison and judicial systems**, while allowing a **flexible and clearly dated adaptation** of the ten-year or even century-old methods of organized crime, while **also simplifying the administration of the law** and the **determination of sentences for personnel whose profession was crime** (with customers, suppliers, and dedicated professional resources, operating under contract) for **periods beyond forty years of clandestine activity**.

If we do not take this road, the structures for maintaining the organizations, some of which have been in place for **30 to 40 years**, risk collapsing and we risk witnessing **mass arrests**, and a form of **erosion of the many elements** located at the borders of legality, as well as fierce **opposition to the implementation of the new paradigms**.

A well-understood adaptation would be in order, and in return a **real collaboration between the police and organized crime would be desirable**.

If there is no **area of diminishment** and **openness** that allows for a gradual evolution towards a stable state of law enforcement, while allowing for **an adaptation of methods, cases, and modus operandi** on both sides of the **administration of the Act**, the overall system may either **fracture** in some way or become more **in ways that may affect other related environments**.

- **Why should the administration of substitution drugs (e.g. electromagnetic treatments) be entrusted to Organized Crime?**

Organized crime is already in contact with customers, can validate the degree of adherence to the adoption of substitutes, and can contribute to a gradual transition rather than an abrupt interruption that would cause individuals to look for disparate suppliers while encouraging the multiplication of initiatives to maintain conventional supply.

In addition, the products sold could be subject to taxes, monitoring and control allowing the regulation of transactions and uses in order to optimize the benefits for the economy (reduction of overdoses, increased surveillance of organized crime), while providing the State with additional capacity to impose additional constraints on the operations of crime, which would also have the responsibility for its own sustainability to comply with the Government's imperatives.

This strategy would have the benefit of **introducing a form of 'Trojan Horse'** within the structures of Organized Crime in order to better control the flow of illicit substances, to unify the largest groups by making them responsible for neutralizing or integrating small groups, and to establish an accurate directory of individual members for the purpose of investigation and strict monitoring of activities that may fuel corruption, collusion as well as any attempt to evade the Laws in force.

The recurrent stratagem (Montreal, New York, Cosa Nostra, Marseille) whereby foreign interference makes use of the provision of neuromodulation technology and synthetic telepathy within Organized Crimes Abroad to gain a share of influence and infiltrate the territory thanks to their complicity received in return, would be considerably undermined in the event that Western governments took the initiative to provide the main groups of Organized Crime similar capacity premises (e.g., only one main unit per region).

FORCED INDOCTRINATION: A DOPAMINERGIC ADDICTION PROCESS

Description of the cognitive attack on the individual

Preparation phase of web browsing environments

Google Search Results Tampering and Orientation, DNS Editing, Amazon AWS Servers, CloudFlare

Use of secret service networks, access, and tools to affect occurrences, stimuli as in the case of an investigation to determine the individual's intentions, orientations, and dispositions

The net created allows the filtering of individuals who are unlikely to respond favorably to targeting

During the night or while sleeping, e.g. First phase :

The subject is tempted to look with interest and surprise at the patterns gradually generated with the effect of depth in 3 dimensions

Audio Indoctrination Message

At the same time, a narrative (audio, V2K - Frey effect) of indoctrination is broadcast to the individual in order to promote the interest of joining the Al-Qaeda group (promise of social and financial retribution, belonging, personal fulfillment and "glory", with a dimension of novelty and renewal vis-à-vis the image and action of the group, seduction that resonates with the search for meaning in human existence, cinematic effect and Hero's journey)

Concealment of the scheme and clandestine deployment

If the process continues and the individual retains their attention on the trained visual, the deep learning system uses the 1G network and/or the 5G-SA network (presumably Huawei or proprietary Indian infrastructure) without intervention, solicitation, or use of an electronic device

Augmented (Extended) reality

After a certain time, the targeted individual is enveloped in an environment produced by stable, realistic, attractive, and visually enhanced hallucinations (colors, animated, and realistic unreal objects)

Social paralysis, isolation

A state of heaviness breeds apathy, and a form of cognitive restraint is installed to slow down cognitive and perceptual processes, allowing attackers to perform more deep learning, mental data theft, conventional manipulation, and mind control, up to and including full control

Terrorist operation in progress, affects Canadian and French infrastructure

Hello,

I am writing to inform you of a major terrorist operation by the Al-Qaeda group (AQIS, AQAP) that is affecting Canadian and French telecommunications infrastructure (synthetic telephony, 5G, 6G, terahertz network).

The network was infiltrated by members of Al-Qaeda and managed to secure assiduous influence over members of the Canadian (CSIS) and French (DGSE) secret services. They are electronically holding hostage some important members or relatives of the French government.

Their operation began with the hacking of my electronic devices in 2020, supported by a ransom demand received in my mailbox. After notifying my employer (Coopérative financière Desjardins) of the situation, my bank accounts were protected, without the attackers being identified. A year and a half later, in 2021, they managed to integrate strategic positions within Desjardins Group, by bribing a file manager at Insurance (Mylène Boisclair), her husband, Maurice Boisclair, and Mylène's father, whose name is unknown.

Under the pretext of reputational issues, Mylène drafted a surveillance contract with recurring payments addressed to Siavosh Shadpey (member of Al-Qaeda, Anonymous, originally a member of CSIS, but fired after 6 months without completing his probationary period), for which the amounts rose in four years to close to one billion Canadian dollars, some of this money having been spent for bribery, and most of it exported through an account with the TD bank in the name of Siavosh Shadpey, before transiting to an account in Switzerland and being converted into Cryptocurrencies to foreign countries where the funds are used to finance the activities of the Al-Qaeda group in Saudi Arabia and India.

Siavosh Shadpey is supported by Serge Langevin of the RCMP, Mélanie Gipeux, a cybersecurity contractor working for Al-Qaeda (AQIS), Marjorie (name unknown, Vietnamese and Caucasian of large height, 2m. 24), working at the DGSE, Ibn Al Assr Daoud (AQAP) and Jean-Marc Nogués, former cybersecurity employee for the Areva Temis nuclear power plant, who sold access and infrastructure secrets to the terrorist group Al-Qaeda through the deep web. They are also protected internally by Jérico Sanches, a team leader at CSIS.

Following reports on this subject, Jean-Marc Nogués and Ibn Al Assr Daoud fled to Riyadh in Saudi Arabia where they have been staying since the beginning of 2025 or the end of 2024.

On the basis of a remote surveillance operation using access to biometric fingerprints and 5G and 6G networks under development (CSIS, DGSE), I was targeted by electromagnetic harassment (cyberstalking, nervous stimulation, mind control) using an unapproved third-party application that the attackers presented as secure by CSIS. A large number of staff were encouraged to connect via this application, which works with a deep learning system by mm wave, microwave, and artificial intelligence. The purpose of this application is actually to facilitate indoctrination by the Al-Qaeda group by targeting the dopaminergic and serotonergic networks of the human brain, making it possible to administer a form of artificial addiction process and neural feedback, to download users' mental data, or to erase their memory for strategic purposes.

A situation of electromagnetic hostage-taking has therefore set in and many agents of CSIS and the DGSE have been forced and see their ability to act hindered, and the terrorists are taking advantage of the sensitive nature of the situation, through blackmail and forced indoctrination. The instigators of the operation act using a privileged position of 'man-in-the-middle' and have access to sensitive data as well as the privacy of the victims.

The situation is of paramount importance because some important members of the government as well as their entourage have been targeted in this way. The scale of the amounts already exported is unprecedented, and could eventually result in a large, violent terrorist operation in the coming years.

Universal wage

In most cases, a fee of about \$10 CAD/hour is transferred through the BRICS system upon simple connection to the application paid on a time basis

Money laundering

A system of rigged bets is in place, working through the interweaving of 4 systems of espionage/voyeurism/total control

Level 1: Passive Access, Bets doomed to failure whose stakes are recovered by the **Cosa Nostra**, which ensures the maintenance of the structure

Participants are regularly called upon to perform various tasks with the promise of obtaining bonuses (VISA-bitcoin card numbers sent and regular withdrawals with promises of larger amounts kept in foreign accounts).

Thus participation entails being profoundly immersed in the "augmented reality" application, with circuits of reward, motivation and compliance deeply affected, asserted and affected.

These promises are generally not kept, and the amounts are then granted for various purposes (recruitment of Boko Haram armies, Islamic State, Al-Qaeda, financing of unknown operations).

When the overall scheme is exposed and the relevant authorities are contacted (secret services, police services) a significant part of the available amounts are spent to identify and heavily corrupt the newly involved resources.

ORIGINAL OPERATING MODEL: Belligerents aim for reproduction of the scheme at other corporations worldwide

1 person targeted after + isolation + visible electromagnetic torture, **spectacular effects** = Bait + lure concerning the effects to conceal silent, painless, invisible samples of mental data

XXXX people involved under the following evolutionary pretext:

- Indignation prepared in particular by fabricating and supporting strange or bizarre behaviors likely to raise questions in the event of exposure or violation of privacy
- Social involvement elicited by manipulation: "It is despicable and irresponsible to tolerate such an individual within your entourage/society/group. Look at his real face" + accurate alerts to grab attention with urgency
- Promise that involvement and investment will reward participants with potential social, financial, and reputational rewards in terms of state-of-the-art monitoring
- Habituation
- Establishing a "justified" and "timely" show
- Addiction and complication for extortion and blackmail
- **No unpleasant or unpleasant sensations**, on the contrary, **artificial addiction affecting the dopamine and serotonin receptors**
- Time invested connected to the application = Time spent on deep learning + installation of persistent back-doors on the devices used + use of iCloud, and/or other cloud-based platforms so likely reproducibility on future devices
- Confidence gained by a so-called approval/participation/security by the CSIS, the DGSE

- Building trust over time through the involvement of reliable groups and individuals (e.g., Desjardins Group)
- Involvement solicited from people of influence under the pretext of "helping a reputable, reliable and essential company", for a good cause
- Solicitation of a large number of people by promise of future profits
- Rationale for exporting extorted funds abroad and using an innovative cryptocurrency system (BRICS) before time investment compensation
- Failure to comply with commitments and promises of full payments by the interferents
- Verified relatives who testify e.g. conventional lie detector, records and highly confidential information
- Network of diverse and impactful informants and contacts
- Chronology and precise identities
- Highlighting Flagrant Violations and Dangers to International Security

Leveraging specific factors

- Diagnosis impossible by medical staff
- Delays in the implementation of legislative structures governing the use of mental data
- A clandestine operation, undetectable, denied, impossible to reconstruct, under the radar
- Between 170 million and 1.7 billion in 3 and a half years
- Cover budgets for different departments
- DGSE
- CSIS was fully neutralized during 2024
- The squad present in 2024 has been paid, comfortably, and is also subject to extortion mechanisms
- Disparate costs of localized corruption
- Ex. SPVM Officers, Organized Crime
- Consolidation of alternative communication networks, contacts and technology

FALSE DIAGNOSIS: Preparation of sleeping agents

Schizophrenia (perception of auditory and visual hallucinations, voice-to-skull), cases observed and recorded in the prison system, on the rise since 2021

The long-standing tolerance of electromagnetic harassment by the secret services, generally resulting in the transfer of responsibility to groups made up of resources operating outside the legal framework of law enforcement (organized crime, secret companies), employing abusive and intrusive practices that find a common qualifier in the term *Gangstalking*, sometimes on behalf of corporations (The permeability of the security system has seen its permeability erode over time and cause complications and serious organizational dysfunctions, which today are perceived and accepted under the pretext of lightening the workload of law enforcement institutions, has opened up immense structural vulnerabilities that completely neutralize security national structures of preponderant states and the global inter-state structures that form the basis of international security.

The highest levels of the French, Italian, Swiss (implicitly and secretly), Canadian, Cameroonian, Australian governments have been targeted by this strategy.

Individuals targeted by voyeurism are directed out of employment and, as possible, into the prison system, waiting to form a group of sleeping agents of indeterminate size when they are released.

The explosion of schizophrenia diagnoses by psychiatric and prison staff reflects an increase in the disruptive use of the Frey effect and artificial mental afflictions.

1 person: 1 communication and training hub for an interference support group, which probably intends to take advantage of the length of incarceration to form groups (with options reduced by inactivity and sentences served outside the labour market), which will be activated upon their release.

To verify, monitor and harmonize a resilient response in permanent synergy between the Royal Canadian Mounted Police, CSIS, SPVM services, and police in general, medical personnel, the Government, prison staff, Health Canada, ISED, the CSST, the Canadian Armed Forces and essential organizations and institutions that form targets of interest from the point of view of Foreign Interference.

Possibility of arranged marriages, mental occupation, interpersonal tourism, and spy relay points being established (e.g., Sleeping Agents, 1-5 military members per person)

Cognitive warfare: To keep in mind, teens and children may be mentally occupied with resources or highly trained personnel

EXPORTED RESPONSIBILITY: Paramilitary deployment, mass murders and ethnic Caste-oriented cleansing

An alarming trend seems to be emerging in the use of neuromodulation technologies on marginalized populations on a large scale.

Violent cognitive attacks are currently underway in South Africa, echoing the Exported Murder Crisis that targeted more than 5,000 migrants in Italy during the year 2022, with some data reporting more than 20,000 victims among the migrant population in Italy since 2014.

More than 10,000 Indian farmers have been driven to suicide through neural control, affect control and total control since 2014, and victims of the Iranian riots, attributable to a similar process, report an estimated 7,000 to 36,000 violent deaths.

A prominent member of the AQAP group stated and claimed to obtain export control and assignment capabilities as early as 2009, corroborating a disclosure by **Praja Virapassam** prior to its execution on 9 February 2026, where it referred to its endowment of very high-tech capabilities to the AQAP groups, and AQJS from the formation of the Indian subcontinental branch in 2014.

Some members of Professor Philippe Guillemant's cohort, specially trained between 2011 and 2020 for the needs and performance objectives of the psychotronic Indo-French paramilitary initiative, thus forming the first offensive unit of the Cognitive Warfare of the 21st century, have stated that they have contributed to the development of a system with a control H.U.D. interface operating in the image of a popular style of video games, the *FPS* (for *First Person Shooter*).

A testimony collected from a member of Indian Organized Crime visually describes the interface of the augmented reality and neural and/or total control environment:

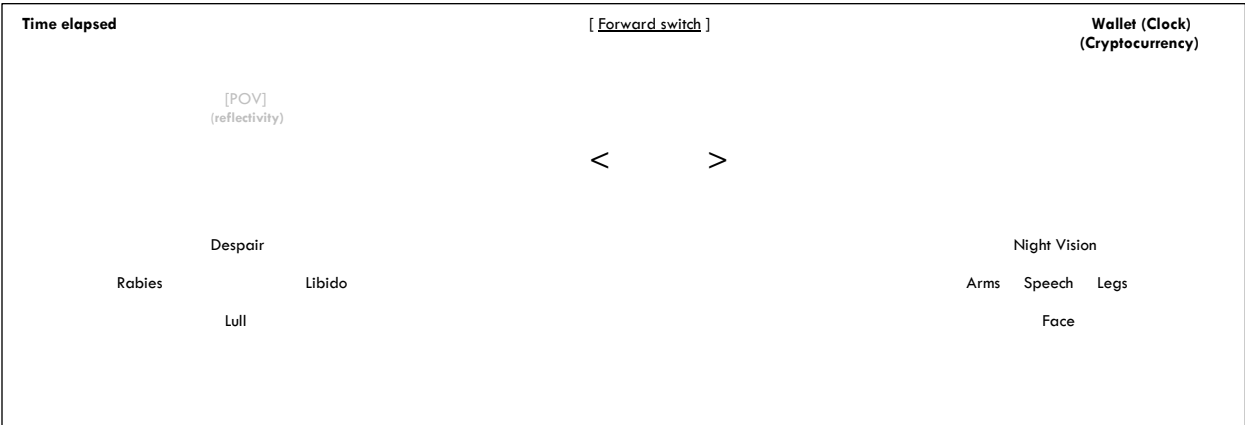


Figure 4: "H.U.D. of the interface used by the belligerents", description collected from the elder brother of Narendra Modi, number 1 in Indian Organized Crime, between March and April 2025

The deployment of this capability was **initially planned** and **envisioned** to **target North American territory**, but the **disclosure of information** acquired over the **past five years** to the **United States Secret Service** (CIA, NSA, FBI) as well as to the **Canadian Government** (CSIS, NSIRA, RCMP) temporarily neutralized the operation, and an **interweaving of social counter-manipulation tactics** made it possible to **locate the personnel of the Al Qaeda parent branch** in the Arabian Peninsula, and the **execution** of **all AQAP members** created the circumstances for a **net gain** within the **rigged betting system** including the profits of these over time.

The Government of Canada, through the **reimbursement of two consecutive bailouts** offered to the **Desjardins Group in 2025 and 2026** to cover its losses over the past four years, obtained payment in the form of **Canada's Sovereign Wealth Funds**, which some journalists have described as a "**war bond**" equivalent to the honorable fine of the abortive off.

The amounts recovered are estimated at **more than \$25 billion CAD**.

SAHEL CONFLICT: Planned Immigration of individuals not treated for COVID-19

Another type of agent is emerging through the immigration in the near future of individuals from conflict zones (e.g. the **Sahel**) to **Europe** and **North America**. The people in question, who have **not been vaccinated** with the **mRNA** solutions administered during **COVID-19**, remain presumably **more difficult to access cognitively** and **mentally**, and the **belligerents** plan to insert them into the system 'offered' by the Government of India.

The purpose of the **ostentatious demonstration of the technology** and the range of means made available is **to give the targeted governments confidence** that **prior adoption of the system** and **blind adherence to procedures make it impossible to detect them** even if the claim is misleading and strategically advanced.

A SHORT BACKGROUND NOTE: Held as hostage from Al-Qaeda

I am sending you this document in order to convey to you crucial information concerning a major problem that greatly affects the national security of the entire country, and the integrity of the national security structures of multiple countries around the world.

I am being held hostage electromagnetically by Al-Qaeda, and the Ancient and Mystical Order of the Rosicrucian Order (A.M.O.R.C.) has been targeted for several years by a radical Satanism group that has taken over it to advance plans for nervous domination and to wage a large-scale cognitive war against the civilian population.

The **triangulation** capabilities acquired by the **2011-2020 cohort** as well as the **300+ psychotronic officers being formed at the time of writing in India** allow the perpetrators to **derive the consciousness functions of every individual neurally linked to the main target in under 10 minutes** computing and calculus.

For the **past 4 years, Desjardins Group** has been targeted through extortion that maintains a situation of **strategic mobbing** that allows the **opening of channels of action** that are **self-financed** by the operation (offering **discrediting services, mind control, technological show/demonstration/attraction** for the purpose of **covert forced indoctrination, augmented – extended - reality infiltration**).

Radical Satanism must be condemned as terrorism, with groups such as the **Rosicrucian Order** operating in such a way as to facilitate the erection and maintenance of **structures of money laundering, neglect of professional standards and moral abuses** of all kinds.

The situation is **serious** and involves the **French secret services, Indian interference**, including **Indian soldiers, a partial but significant paralysis of CSIS, the Desjardins Group** and probably other financial institutions in Canada, and a group of individuals who took part in an undercover operation in a concerted effort to weaken the **Canadian and North American** economy as a whole, to **place foreign agents clandestinely** in an **unconventional warfare effort**, and to carry out a **false-flag operation** that puts the governments of the **United States and Canada** at odds.

The involvement of Desjardins Group is problematic because they were impressed by the DGSE's cutting-edge technologies and were targeted by a massive theft of mental data. Paradoxically, a number of high-ranking employees integrated into organized crime exert a network of influence to keep the collusion and corruption scheme in place, and to stifle alerts.

The people in question could be at the end of their careers, retired, on sick leave or in fictitious jobs that allow them to regulate the flow of money.

- Infiltrate North American territory through Canadian infrastructure, where they identified flaws
- Leverage the specificities of institutions protecting national security, including the separation between CSIS's civilian intelligence service (CSIS) and the Royal Canadian Mounted Police and Police Response Groups
- Open a permanent privileged channel of action through corruption and the involvement of police and intelligence agents

ABOUT INTERFERENCE: Original plans

WRITTEN AND SENT TO THE RCMP ON OCTOBER 10, 2025

The plan of operation relayed in this article came to a halt as soon as the RCMP, CIA, Mossad and DGSI were contacted.

The DGSE, Al-Qaeda and the Indian military and secret services deploy a heavy mind control capacity to support a significant number of accesses to the 'consciousness function' through a favorable demographic ratio and disruptive augmented reality technology.

After equipping al-Qaeda with mind control capabilities, Narendra Modi's government intends to take advantage of the surprise effect of this opening to affect the integrity of the North American national security structure. Modi is setting up World War 3 on North American soil, and intends to take on the challenge of acquiring the nervous systems of the Canadian population in large numbers, to carry out silent mental occupations and to bleed the economy of Quebec and the country, as is the case with the problems related to the Digital Shift of Santé Québec, where it is likely that Indian or French soldiers are carrying out first-rate psychotronic operations.

Targeted mind control and nervous system enslavement systems are extremely effective, and current technologies have created opportunities for unconventional warfare.

By agreeing to perpetuate a situation initiated by organized crime and members of the DGSE, the Movement has seriously weakened national security by financing the corruption of CSIS, which will be completely neutralized in 2024, and the agents must be questioned urgently to assess the situation.

Initially using alleged domestic violence issues as a pretext in order to attract attention and promote a booby-trapped application, and to contribute to the development of an organized crime and money laundering network within the Desjardins Group, the Nogues family, Evelyne Comtois-Dinel, benefited from the support of members of Al-Qaeda infiltrated within the DGSE to introduce elements of Indian interference. of organized crime, corruption, collusion and privileges, while extending its influence to positions of high responsibility that they have managed to corrupt in the long term.

Quickly, a murder conspiracy prompted the company to accept the terms of the Crime, and a situation of human trafficking was set up, where the real targets were and remain the individuals of interest, SPVM, Rosicrucians, Desjardins, members of the Government, etc. who were administered a set of deep learning processes of their mental and behavioral processes.

Gaining influence, the application has allowed foreign interference to generate large sums of money and finance terrorism, the war effort and the impoverishment of the Quebec economy.

The complacency of our services acquired, three ministers resigned and a psychotronic attack launched by Indian and French interference, in particular, was added to the efforts of the PRC to start an unconventional war on Canadian soil.

The blackmail mechanisms in place were enough to neutralize the corrupt staff, some of whom ended up joining Al-Qaeda, the terrorist group making the money of the Movement's taxpayers and employees its own.

Following a report made about them, Jean-Marc Nogués (recruited by **AQAP**, human trafficking, pimping, terrorist conspiracy and embezzlement) and Sarah Nogués finally fled to Saudi Arabia, and/or the Republic of Iran.

They are staying there with an individual of unknown name suspected of being linked to both the downing of ***Air India Flight 182*** on June 23, 1985, and ***Air India 171*** on June 12, 2025, 40 years apart.

Two of his accomplices are found to have left the country with special dispensations from the Indian Government (provided by President Droupadi Murmu) and are linked to the theft of mental data that targets the entire CSIS workforce, part of the RCMP, part of the Canadian Government, and the entire Quebecer/Canadian population.

One of them is wanted for murder (Mélanie Gipiux), and the other (Siavash Shadpey) claimed to be the author of a cyberattack leading to the downing of ***Air India Flight 171***, in direct complicity with Narendra Modi, who through this operation proceeded to eliminate an opposition member from his former party (BJP).

The 40-year gap is all the more troubling given that the vast systemic paralysis issues affecting CSIS in 2024 echo the year the intelligence service was created in 1984, which was already heavily criticized at the time for reporting serious breaches of intelligence integrity. Events involving the suppression of evidence and the breach of procedures had already been reported in the management of the ***Air India bombing. 182***

In 2025, similar problems surrounded the tragedy of the crash of the Indian airline's plane just after takeoff, even though a former CSIS agent with a degree in Aerospace Engineering (Siavash Shadpey) had admitted guilt of his own accord, even proudly claiming responsibility for the mass murder of the 290 victims of the plane in question.

Although they had undercover agents in contact with their former colleague, and had state-of-the-art synthetic and/or V2K telepathy technologies, no denunciation was made by CSIS on this subject, with some agents claiming that they were "following the lead of the **DGSE** regarding the management of this case" and others simply arguing that the sums of money released by "Al-Qaeda" – mentioned knowingly, resulting from the embezzlement of funds from the Desjardins Group, were such that the complicity of a large part of their department had been bought by the terrorist group.

A vast money laundering system has been set up and operates between the Desjardins financial cooperative, Montreal Organized Crime, Al-Qaeda, the Rosicrucian Order around the world, Marseille Organized Crime, New York Organized Crime, Sicilian Organized Crime (Cosa Nostra), and the **DGSE's Clandestine Heritage**.

The operation goes through the BRICS cryptocurrency system, and most of the funds should be traceable because the criminals must make withdrawals from this system to their bank accounts and/or are granted a *pseudo* minimum wage equivalent to **\$10 CAD per hour of connection** to the application and the funds in question are potentially paid at the same time to a significant or even entire part of the participants.

To this end, a system of rigged bets has been set up and benefits the Cosa Nostra in the medium and long term, which encourages "for the sustainability of operations" individuals who contribute to money laundering to recover only a tiny part of their winnings, while keeping most of the funds received on an online platform. for subsequent bets on the subject being tested, and the outcome of his choices.

An investigation had been conducted by NSIRA in 2024, but the response obtained reflected the outdated trust placed in the DGSE and the French secret services.

L'appareil situé en dessous du mien était impliqué dans le piratage de mes appareils, tout en me révélant que je n'étais pas sous enquête de la part du SPVM. J'ai donc orienté mes recherches vers des organismes comme la GRC ou le SCRS.

Au fil du temps, j'ai commencé à recevoir des communications auditives, sans pouvoir déterminer leur provenance dans mon domicile. D'abord sous la forme de sons de clics dans mon appartement, puis sous la forme de voix et de sons délivrés dans mon centre cérébral du langage.

Des recherches sur internet m'ont permis de découvrir l'existence de techniques de communications telles que le V2K (effet Freq), ou encore la télépathie synthétique.

Les personnes en question commentant les choses que je vois (ex. lors de mon travail, ou mes activités quotidiennes), il est clair que les technologies employées permettent de transmettre les informations de mon centre cérébral de la vision.

L'un des messages que j'ai reçu à répétition mentionnait que j'avais été vendu au Crime organisé et à la recherche illégale de stimulation neuronale, et que les individus qui en étaient les acteurs étaient à la fois protégés par les Services secrets et le Crime organisé.

Deux ou quatre de ces personnes semblent, de leur propre aveu, faire partie du SCRS (Siavosh Shadpey, Mélanie Gipiux), et deux autres, n'ayant pas mentionné leurs noms de famille (Serge, Marjorie) affirment faire partie de la GRC ou du SPVM. L'achat d'un multimètre à radiofréquences m'a permis de constater des niveaux dangereux d'exposition aux ondes électro-magnétiques à mon domicile, même lorsque l'électricité à mon appartement est coupée. Par ailleurs, étant propriétaire de deux iPhones (13 Pro Max et 15), les individus en question ont accès à ma caméra ainsi qu'à leurs capteurs infrarouges de mes téléphones et télévisions, ce qui leur permet de m'espionner en permanence, tout en me faisant parvenir des commentaires désobligeants. Ils ont en outre été instrumentaux dans une situation de mobbing par mon ex-employeur (Desjardins), qui a mené à mon licenciement en 2023.

J'aimerais si possible qu'une enquête soit ouverte afin de mettre un terme à cette situation. Au moment où j'écris ce message, les personnes concernées ont accès à ce que fais et lisent donc ce courriel. Il est donc probable qu'elles prennent des mesures afin de ne pas être suivies durant les prochaines semaines.

Je comprends qu'en 2024 l'emploi de méthodes de surveillance ciblées puisse être nécessaire, mais les interférences à mon système nerveux, en plus de m'exposer à des radiations par ondes électromagnétiques et magnéto-thermiques qui pourraient s'avérer toxiques ou délétères à ma santé, sont insupportables et me privent de mes libertés les plus basiques et fondamentales.

Bonjour,

Je vous écris car je suis constamment sujet à des pratiques d'harcèlement électronique et de stimulation neuronale, de la part de deux personnes qui affirment faire partie du SCRS. J'ai déjà pris contact avec un agent du bureau des enquêtes indépendantes, qui m'a orienté vers vous ainsi que l'OSDNR.

À la fin de l'année 2021, j'ai commencé à observer des signes de piratage informatique sur mes appareils électroniques (ordinateur personnel, ordinateur de travail, téléphone cellulaire) et après plusieurs tentatives de résoudre la situation de mon côté, j'ai contacté le SPVM à plusieurs reprises afin d'obtenir de l'aide en matière de cybersécurité.

Le premier agent qui s'est présenté à mon domicile m'a informé qu'en temps normal, si les moyens classiques de protection ne suffisent pas (anti-virus, pare-feu, etc), les méthodes employées pourraient provenir d'une enquête anti-terroriste par la GRC ou les Services secrets.

Durant les semaines suivantes, ayant déconnecté les composants électroniques d'accès au réseau (antennes bluetooth, Wi-Fi), j'ai pu obtenir des preuves du piratage de mon ordinateur, qui se connectait à un réseau inconnu alors qu'il était déconnecté physiquement de mon routeur.

Après avoir à nouveau pris contact avec le SPVM, j'ai par la suite obtenu informellement des informations de deux autres agents qui, sans me le mentionner directement, m'ont indiqué par des signes vers le bas, que l'occupant de

Canada

Currently, the DGSE (Directorate General of External Security, responsible for most of the French government's clandestine operations) is not officially assigned to Canada, and since 2022, the service has undergone a major reshuffle, and the description of their mandates has been revised. The information available to the public mentioning the Director of the DGSE as the "boss" of the DGSE, and "former boss of the DGSI", combined with the career history of the current President Emmanuel Macron, also suggests a (very) likely privatization of the French secret services as a whole.

Many agents have nevertheless been clandestinely deployed in Quebec since then, and a vast operation is underway on Canadian territory, in particular that of Quebec where the French secret services have launched a coordinated offensive with the Indian government, in order to pursue and support the efforts of Indian interference in an aggressive manner.

The long-standing collaboration between France and Quebec and a sense of cultural proximity that is perceived throughout the Francophonie has created a serious opening that has allowed DGSE agents, some of whom **claim to be long-time members of Al-Qaeda** (see List of Three Supervisors Operating for Al-Qaeda, and List of Five Individuals Trained in New Delhi Operating for Al-Qaeda), to partially paralyze CSIS's intelligence capabilities, by isolating the service vis-à-vis the RCMP and potentially the Canadian Government, which since then have not received the support and intelligence capacity provided for by their mandates.

In addition, at least three double agents operating for the terrorist group for a long time in supervisory positions (3 prosecution teams) have used their positions to copy sensitive information including highly secret access, to cover up other undercover agents, and to secure a large area of influence (purported to affect the bulk of the workforce, excluding the main chain of command – "We chose the BRICS" – implying that the RCMP and the government were not consulted), which resulted in a general silence regarding the situation surrounding the Desjardins Group and French and Indian interference.

The corruption of this significant part of CSIS's services, as well as the deep learning to document their functions of conscience, have given the Indian interference, terrorists, and military mind control capabilities over affected agents, regardless of Canadian or American capabilities.

The ease of use of targeted nervous system servo systems combined with the considerable effectiveness of current remote neural monitoring technologies has created lucrative opportunities for luxury entertainment, and clandestine services are offered by secret agents to a high-end clientele. A privileged client can export and integrate

his volition to civilians, without their knowledge and in a transparent way. This form of interpersonal tourism can raise issues of incoherence, attribution of responsibility or evolve into a form of game conducive to abuse of power, collusion, and spread corruption beyond the occurrence concerned.

The information gathered over time and relayed here comes from a counter-examination that I conducted with my attackers over a period of four years. The aggressors feeling out of reach because of the nature of the means they employ, the imbalance of forces and believing from the outset in a guaranteed success, they have from time to time let slip information that I have tried to discern by taking advantage of the diversity of their points of view.

In order not to take any risks, Desjardins decided to hire the services of YQ's neighbours. 4 years later, the amounts spent were estimated at \$230 million (although company representatives mentioned amounts of about \$4 billion in an effort to discredit and conceal the company).

Serge Langevin (1m. 94, 57, Caucasian, orphaned from birth, covers Mélanie Gipiux, his ex-spouse, mentor of Siavash Shadpey, RCMP, Organized crime, Al-Qaeda) is a present or former RCMP agent who has long-time ties to the Organized crime and Al-Qaeda.

He's a crucial piece to the plan and operates to dissimulate the scheme from being dealt upon by the RCMP while being covered by a few colleagues who run interference to keep him out of trouble.

As part of the RCMP/CSIS regular strategy to run neural surveillance on targets, he mentors and works in tandem with Siavash Shadpey while putting in place a man-in-the-middle social engineering attack with the participation of ex-girlfriend Mélanie Gipiux.

In the earlier years, worked to conceal Mélanie's murders of their daughter, 5, and her mother, 51. Has a solid network of associates and mentioned on one occasion that his reputation was 'to-be-preserved at all costs'.



Mélanie Gipiux

Like some of the 28 other resources trained in India between 2011 and 2020, both have a tumultuous past. Mélanie (1m. 77, 45, Indian mulatto) is a serial killer, with 5 victims including 3 human sacrifices perpetrated on Indian territory during her studies in Neuroscience and Opto-genetics.

Her first two victims were her family, her daughter, with whom she had an incestuous relationship, and her mother, who was murdered when she discovered her disappearance.

Murdered Mylène (name unknown, presumably Boisclair) by mind control of her husband, presumably named Maurice (name unknown, presumably Boisclair) by a gun-inflicted wound to the head.

Has advanced hacking and triangulation techniques skills, and a privileged position that allows her to run the scheme by unwillfully connecting consciousnesses together, triggering Forced indoctrination processes remotely and can operate in a fully neural-integrated environment to administrate the global network of the disruptive *augmented reality* application.

Lived in Montreal, Quebec from 2002 to 2025, the later years without legal status to conceal her presence from the authorities and escape enquiries about past murders. Fled to the Residence of Narendra Modi in Gujarat, India, when exposed by this report.



Siavash Shadpey

Siavash Shadpey (1m. 78, 33, Iranian) is a dangerous individual who completed his Aerospace Studies (Master level) at the University of Toronto in 2019. He has claimed being the main operator behind the Air India 171 air crash and the Caribbean flight air crash described at the beginning of this document.

Having made his way through refugee networks upon his arrival in 2005 in Ottawa, Canada, he went through security checks presenting himself as an orphan seeking refuge on Canadian Territory, fleeing from Iran with his sister.

A long-time recruit for Al-Qaeda (AQAP, AQIS), he's the half-brother of Ibn Al Assr Daoud described earlier.

He was mentored by Melanie Gipiux on behalf the terrorist group and was sheltered and guided by Serge Langevin (ex. Boyfriend of Melanie Gipiux, 1m. 94, RCMP) to go undetected all the way to the entry probation for CSIS, which he didn't complete, having failed to meet all criteria. Nonetheless, he was able to sustain sufficient support from his ex. Team Lead (Jérico Sanches) and other CSIS agents working covertly with the Organized crime who helped him put the collusion scheme in place from inside the civil National Security institution.

Backed by Melanie Gipiux and Marjorie Niwycjna, with complicity from the Cosa Nostra, he contributed to a fraudulent contract with the Movement Desjardins to run 24/7 surveillance, mobbing and to attempt the murder by exported responsibility of Yoann Quillin, which led to the situation mentioned here.

Michel Aqueux (1m78, 65, Caucasian/North African, joined Al-Qaeda in 2002 as a supervisor of Marjorie Niwycjna, DGSE, AQAP)

(Friday, March 20, 2026, 10:17 p.m.) Michel Aqueux admits to having had "a certain facilitating role" in the implementation of the September 11, 2001 attacks in New York. His membership in AQ or at least his complicity dates back to around 2001.

He states (supported by Siavash Shadpey, then by a member of AQAP on Tuesday, March 31, 2026, 00:58) that he has had contacts with Mohamed Benbouziyane (former no. 3, with a role more focused on the establishment of self-financing structures or transactional partnerships in order to capitalize on the levers and avenues available in the aftermath of September 11 and during the 7 years that followed (between 2002 and 2009).

My hypothesis is that Mohamed was recommended by Michel Aqueux and the doubt remains about a potential opposition from the French government of the previous era (veto or refusal to actively contribute to the Afghan conflict, then Iraq).



Marjorie Niwycjna (2m24, 32, Vietnamese, member of the underworld, DGSE, AQAV)
(team **Michel Aqueux**) Human trafficking, tourism, entertainment, rental, capture, use as a mule (mobbing, with long-term financial transaction), attempted murder. Has an older sister who has a prominent position in the Montreal underworld (*Pègre*).

Takes part in a trafficking of consciousness function accesses passed from the DGSE to the underworld or privileged clients.

Ibn Al Assr Daoud (*deceased*)

Recipient of a substantial inheritance from his parents, both Iranian and Italian diplomats, struggling to renew and bring novelty to his daily life, plagued by marital difficulties that he tries to reduce by using the services of sex workers (**7 femicides – 5 escorts** of various origins, **2 Western tourists** having accepted payments, **6 murders** of African workers who came with a promise of employment to the Daoud home, located on the outskirts of Riyadh in Saudi Arabia, with occasional cannibalism, preservation of macabre memories and display of decapitated heads preserved, presumably in formaldehyde, in the basement of the family residence), for having tried to prevent the removal of the condom during paid sex), Ibn Al Assr Daoud obtained the luxury services of a team from the DGSE, within which the controversial market

for the rental of nervous systems as luxury entertainment was gradually established as a loss of income to be capitalized on, the effectiveness of technological means no longer having to be demonstrated and the gradual reduction of the workload consequently generating restricted salary scales. A draft plan was developed by Marjorie Niwycjna, Mélanie Gipiux, Siavash Shadpey, Ibn Al Assr Daoud, who contacted Jean-Marc Nogues to offer him to join their team and benefit from mind control and potential financial benefits to come, under certain conditions. Jean-Marc's role includes introducing IAD to the Rosicrucian, serving as a Caucasian token to conceal the team's allegiance to Al-Qaeda, and later, triggering the circumstances and the beginning of a situation of mobbing a high-performance employee within the Desjardins Group. They will be supported by Jérico Sanches of CSIS (SCRS), and Serge Langevin, a former RCMP member who has been transferred to a case processing department within the Government of Canada.

Five of the twenty-nine individuals trained between 2011 and 2020 in New Delhi in preparation for the current operation, supported by the expertise of Professor Philippe Guillemant. The resources were recruited for the purpose of offensive use of neuromodulation techniques abroad and completing a 9-year specialized training in Neuroscience and Optogenetics in India in an effort to prepare for offensive use, for the purpose of infiltration as non-conventional warfare officer-engineers, cognitive warfare, sabotage and espionage agents to provide them with a quantum resonance-based genetic location and mapping capability for the purpose of establishing a clandestine repertoire of functions of consciousness of a vast body of people. From an individual whose brain functions are accessed for the purpose of synthetic telepathy, the connected resources can thus be located and their own data, equations and functions of consciousness can be obtained, calculated and accumulated in order to affect their decision-making processes and gain access to their environment.

Geneviève Marie (1m. 80, Brunette of Caucasian type) is a Development Engineer who contributed to the development of an Extended Reality and human cybernetic network communication platform employed by the DGSE, the *Meta-group* (presumably, *advanced to create a diversion, obsolete*) as well as by Al-Qaeda.

It includes one victim sacrificed and abandoned in the Ganges during his studies in India, as well as another, prior to undetermined circumstances.

Desjardins Group's involvement since the end of 2021 has allowed the interference to accumulate more than \$170 million CAD through recurring expense accounts concealed by two corrupt resources that have since left their positions.

Nine people who have worked in important positions in the company (3rd place after that of President), have received and are still receiving salaries from fictitious jobs, and one of them is the father of the person who was responsible for hiding the expense accounts.

Guy Cormier, former President of Desjardins Group, receives an annual collusive envelope of about \$10 million CAD per year for facilitating the scheme and maintaining the situation of diversion to a resource that claims to be the number two of an important branch of the Al-Qaeda group, Ibn Al Assr Daoud. He is closely supported by Jean-Marc Nogues, appointed Commander-in-Chief by Narendra Modi, and quickly became a leading figure in the terrorist group (number 3 AQIS), which has declared that it has obtained over the years the largest funding in its history.

These people are instrumental in maintaining the secrecy surrounding the scheme, as they all have the fear of being arrested for collusion, corruption and embezzlement.

Another 20 people formed an organized group of 6 or more people who concealed their support for the terrorist group al-Qaeda, before integrating other resources over time, including the nine previously mentioned.

When the magnitude of the amounts permitted, they were able to bribe most of CSIS as well as members of the police services.

A money laundering structure has been developed and is transiting to the BRICS cryptocurrency system, so increased monitoring of such transactions could make it possible to detect and trace the profits of the operation.

2014-2020: Previous timeline

For clarity, the information will be provided by following the chronology of events and facts that have been detected, accumulated and understood during the last four years.

Before 2014: Narendra Modi's government exposes and equips the al-Qaeda group with high-tech anti-terrorism

Important members of the incoming Indian government are in contact with active members and leaders of the terrorist group Al-Qaeda. Prime Minister Narendra Modi, who is about to be elected to his first term, counts among his acquaintances an individual of Moroccan origin who would later become Al-Qaeda's No. 3, Ahmed Mustafay, probably through one of the refugee networks to which he (Narendra Modi) contributed. One of the contacts I was able to cross-examine (Praja – *last name unknown*), turned out to be linked to the Al-Qaeda group, for a long time. Close to Narendra Modi, operating as an Advisor, expert in Neuroscience, ambassador of the Indian Government in the French Government, and close to the family circle of President Emmanuel Macron since his election period. Caught off guard, it reveals that al-Qaeda has been equipped with high-tech, including neural (mental) control and perception altering capabilities. Later, these abilities would prove to be intended to serve as a weapon of war (use of the human body as a vehicle and means of infiltration) and forced indoctrination.

2017: the future French President and his close entourage are approached by Praja Virapassam and receive "augmented reality" as a "gift from India"

- They were only aware last year (2025) of certain aspects that had been strategically concealed by N. M. and Praja Virapassam
- Complex situation aimed at weakening NATO, following the infiltration of the French presidential family for nearly 10 years
- Approached during the electoral process (before receiving conventional protection by the internal secret service DGSI)
- **Taken aback by a parallel action by an undetermined number of agents led by the N.M. government, in particular through ACJS, and/or organized crime groups from different areas, to encourage the corruption of more resources within the DGSE**
- **Several inter-state teams, made up of double or triple agents, synchronized their strategies**

A new environment of entertainment and communications is presented and offered to the future French presidential family, as a "gift from India", under the name of "augmented reality".

The technology in question leverages the latest advances in mental augmentation, extended reality, and millimeter wave and provides access to an entertainment platform that includes technological insights.

Features presented include synthetic telepathy, as well as intervention capabilities that allow control of targeted individuals. Over time, four ongoing investigations are available, all conducted by DGSE teams on Canadian territory.

Praja* then began a long-term infiltration within the Presidential family, without revealing her links with Al-Qaeda.

2020, Desjardins Group's approach

In 2020, a close collaboration between the governments of Narendra Modi and Emmanuel Macron began. The French secret services ceased to be officially stationed in Canada, and the Montreal premises were decommissioned. The organization and staffing of the DGSE are being reviewed in order to integrate a new approach based on the deployment of surveillance capabilities by synthetic telepathy and direct access to the executive and motor functions of the targets.

A major prepared operation was launched in Quebec, including by some DGSE and CSIS agents who had joined the Al-Qaeda group after taking office.

At the same time, I started working at Desjardins Group at the end of December 2019 as a Workforce Planning Advisor. In order to make my work more efficient, I developed optimized tools that I could make available to my colleagues, which took up a significant part of my free time, beyond the usual working hours.

During a call made by Jean-Marc Nogués and/or Mélanie Gipiux, who impersonated an SPVM officer (instigators and go-betweens of the mobbing) to a case manager working in the Insurance Department of the Desjardins Group, long enough to recruit her and make her a strategic element destined to disappear. Its usefulness was to agree to convince the Movement to grant funds to their project on a recurrent, long-term basis. The first step was to convey a sense of urgency to encourage premature decision-making, in a "foot in the door" mode of manipulation, by creating a precedent of superfluous contribution.

The company, as a financial cooperative, is one of Canada's core institutions and benefits from the national security mandate fulfilled by CSIS and the RCMP. For two years, payments were revalidated regularly and their necessity was systematically forged by the system's permanent matchmaker mechanism.

BLACKMAIL ATTEMPT: Sextortion Ransom demand (received in late January or early February 2020)

I received the following ransom note, which threatened to damage my reputation with my relatives and my employer, the attackers tried to access my bank accounts but were blocked.

Objet : You have been hacked

Hello pervert, I've sent this message from your Microsoft account.

I want to inform you about a very bad situation for you. However, you can benefit from it, if you will act wisely.

Have you heard of Pegasus? This is a spyware program that installs on computers and smartphones and allows hackers to monitor the activity of device owners. It provides access to your webcam, messengers, emails, call records, etc. It works well on Android, iOS, macOS and Windows. I guess, you already figured out where I'm getting at.

It's been a few months since I installed it on all your devices because you were not quite choosy about what links to click on the internet. During this period, I've learned about all aspects of your private life, but one is of special significance to me.

I've recorded many videos of you jerking off to highly controversial porn videos. Given that the "questionable" genre is almost always the same, I can conclude that you have sick perversion.

I doubt you'd want your friends, family and co-workers to know about it. However, I can do it in a few clicks.

Every number in your contact list will suddenly receive these videos – on WhatsApp, on Telegram, on Instagram, on Facebook, on email – everywhere. It is going to be a tsunami that will sweep away everything in its path, and first of all, your former life.

Don't think of yourself as an innocent victim. No one knows where your perversion might lead in the future, so consider this a kind of deserved punishment to stop you.

I'm some kind of God who sees everything. However, don't panic. As we know, God is merciful and forgiving, and so do I. But my mercy is not free.

Transfer 1750\$ to my Litecoin (LTC) wallet: `ltc1qq4glf84q5s7427ge46932585s8nl5k32300g`

Once I receive confirmation of the transaction, I will permanently delete all videos compromising you, uninstall Pegasus from all of your devices, and disappear from your life. You can be sure – my benefit is only money. Otherwise, I wouldn't be writing to you, but destroy your life without a word in a second.

I'll be notified when you open my email, and from that moment you have exactly 48 hours to send the money. If cryptocurrencies are uncharted waters for you, don't worry, it's very simple. Just google "crypto exchange" or "buy Litecoin" and then it will be no harder than buying some useless stuff on Amazon.

I strongly warn you against the following: * Do not reply to this email. I've sent it from your Microsoft account.

* Do not contact the police. I have access to all your devices, and as soon as I find out you ran to the cops, videos will be published.

* Don't try to reset or destroy your devices. As I mentioned above: I'm monitoring all your activity, so you either agree to my terms or the videos are published.

Also, don't forget that cryptocurrencies are anonymous, so it's impossible to identify me using the provided address.

Good luck, my perverted friend. I hope this is the last time we hear from each other.

And some friendly advice: from now on, don't be so careless about your online security.

Mélanie Gipiux said that the use of standardized emails routinely allows hackers to protect themselves and hide the veracity and origin of the threats made.

The attackers carried out their threat while concealing the communication channels they were using. Their primary goal was actually to trigger a mobbing situation in order to justify collective surveillance, to promote a booby-trapped application granting full access to my privacy, to increase user interest by presenting technologies inaccessible to the general public, and to solicit funding from the company while controlling/forging (deep fake, synthesized voices by A.I.) information transmitted, received, and access to content, essentially functioning as a man-in-the-middle attack.

The mention of the Pegasus software allowed me to determine that the people in question were using means usually reserved for routine surveillance by agents of various secret services around the world.

Impact of secret societies (secret societies)

The influence of societies based on shared secrecy is generally excessive given the limits of their existential impact.

The membership of new members through the means promoted by public exposure integrates any contribution of this type into a pyramid system that rewards privileged members, admitted through selective recruitment based on practical benefits, contributions of influence, financial means and additional perspectives (secondary recruitments, access points to privileges or social networks, etc.), skills in demand, mainly in the field of very high technology).

The action of these networks is carried out in the shelter of societal regulatory structures. From the point of view of personal motivation, the role of secrecy is to maintain and increase the group's hold on the individual.

The nature of the protected facts, events and rituals is necessarily criminal, sordid, and villainous in nature, because the obligation to escape the law is accompanied by a transcendental aim integral to the discourse of the most influential members (nihilism, Satanism, pronounced taste for cruelty, injustice, immorality and the obtaining of a mischievous impunity).

The vital need to maintain this impunity by all available means makes secret societies important hotbeds of corruption, money laundering, extortion facilitation, and intensely targets members of the police, intelligence services, and in positions of authority, especially in active governments.

Heads of state are approached at the beginning of their mandate on a routine basis and have sometimes joined the circuit beforehand to support their candidacy during the electoral process or to obtain favors during their previous career. In this sense, a form of interference with exponential effects is put in place when the targeted individual does not demonstrate sufficient independence and divergence.

The influence of the Rosicrucian Order is essential and instrumental in achieving the objectives of the current operation.

At the beginning of 2025, the resource responsible for burying the recurring expense accounts related to the operation (*presumably named Mylène Boisclair or Mireille, name unknown, possibly Boisclair*) was murdered by her husband, who was also involved in the project.

Mélanie Gipiux admitted that she intervened to control the latter, the goal being to eliminate the main bottleneck in charge of monitoring and granting payments, mandated by the company in the awarding of the contract between the Desjardins Group and Siavosh (or Siavash) Shadpey, potentially under the pretext of reputational issues.

It also demonstrates a social dimension that places it among the most influential and reputable companies in the country.

In 2019, the company was targeted by a massive data theft that raised questions about the effectiveness and rigor of its security standards.

As a key institution, the Movement should not have been involved in the financing of the operation and its contribution created a breach and vulnerabilities that seriously undermined the national security of Canada, North America, and globally.

The scale of the financing sustainably fuels the corruption of terrorist groups (AQAP, AQIP), secret agents, members of governments, heads of state, police officers, civilians, and a multitude of individuals who contribute to money laundering through transactions, rigged bets, and other schemes within the Rosicrucian networks.

Some of the payments are made through the DGSE/Desjardins application (regular basis depending on the time of connection), or in cryptocurrency potentially through the BRICS system (augmented reality application reserved for privileged users who pay to rent mind control and receive payments for corruption purposes).

Access cards to this system were distributed by the Indian government (received electronically by Siavosh (Siavash) Shadpey and transmitted to users of the two applications - DGSE/Desjardins, augmented reality).

If we add to this the coincidence of meaning, from Desjardins to Riyadh (translation "The Gardens"), the potential of the operation as well as its main objective, that of a false flag operation, appears trivial.

Desjardins Group was also affected by a large-scale theft of mental data, as were other essential institutions such as CSIS, the SPVM, part of the previous and current government. Given the significant resources deployed, it is likely that other companies, institutions, and targets of interest have been infiltrated or compromised.

The provision of mind control and high-tech capabilities by Narendra Modi's government to the Al-Qaeda group, and the support obtained from Emmanuel Macron's government, as well as the granting of significant funding by the Desjardins Group, seriously weakens international security, because the amounts raised transit Al-Qaeda (Riyadh) and the funds redistributed, through the international conventional system, the Clandestine Heritage of the DGSE, the Cosa Nostra and the BRICS Cryptocurrency system are traceable and the path of the funds can therefore serve as evidence of complicity in an effort to weaken the structure of NATO and Western diplomatic relations.

CAUSE FOR CONCERN: Fraudulent Inter-State Community of Practice of the Secret Services (France, India, Canada; V2K)

Unsafe practices and GPS jamming

Using the IP address of a location service (e.g. iPhone) on a device under surveillance by a secret service to connect it to the aircraft's GPS. Immediately after takeoff, and before the autopilot is engaged, the aircraft's navigation system detects that the arrival coordinates have been exceeded, and initiates a slowdown of the engines, as if to 'park' the aircraft on the arrival runway

The "Airplane mode" of phones usually keeps the location activated, allowing access by surveillance systems

With hundreds of thousands of commercial flights per day, and flagship aircraft models (e.g. Airbus, Boeing), it is possible to scan the standard IP addresses of navigation systems in order to establish a directory of parameters, and navigation manuals and/or certain technical data from manufacturers can be more easily accessible or even made available to qualified personnel (e.g. holders of a university degree or a doctorate in engineering Aerospace)

A member of the secret service can easily contact an airline to obtain a detailed list of passengers on a particular flight

Complacency

- Witness to a casual attitude of the secret services (possibly Indian or French) regarding a certain awareness of the state of affairs, considering the occurrences of computer attacks on commercial flights as a statistic

Emergence of a social status conducive to abuses of power, authority and a form of criminal immunity

- "We are the kings of the world", the precariousness of employment due to the impossibility of a change of career environment and the over-protection of positions is gradually leading to a form of ethical laxity and a lowering of standards of professional rigour.
- In combination with the group effect, and in the absence of disciplinary procedures vis-à-vis assiduous compliance with ethical codes, often perceived as guidelines that can be ignored, a rapid desensitization of recruits at the beginning of their careers can lead to negligence affecting respect for human rights
- The integrity of supervision and continuous improvement practices can be compromised by social contact between professionals, as can organizational culture
- The "pantomime" aspect of mind control when it affects the body language or attitudes of targets can erode empathy and create a playful and addictive craze, individually or collectively
- The ease of use of targeted nervous system servo systems combined with the considerable effectiveness of current remote neural monitoring technologies have created lucrative opportunities for luxury entertainment, and clandestine services are offered by secret agents to a high-end clientele. A privileged client can export and integrate his volition to civilians, without their knowledge and in a transparent way. This form of interpersonal tourism can raise issues of incoherence, attribution of responsibility or evolve into a form of game conducive to abuse of power, collusion, and spread corruption beyond the occurrence concerned.

Conflicts of interest and outrageous manipulation of civilians in positions of high responsibility

- Multiplication of independent initiatives for profit resulting in a form of Organized Crime internal to the intelligence/secret services

Abandonment of professional mandates

- Replaced by criminal initiatives that promote the accumulation of misappropriated funds and result in blatant openness that jeopardizes the confidentiality and secrecy of high-tech and operational methods, processes and structures, sometimes to terrorists, criminals, and/or civilians
- A significant part of the DGSE joined the Al-Qaeda group

Investigators have made a chilling discovery in the preliminary investigation into the Air India Flight 171 crash which killed 260 people in June.

Just seconds after take-off, both of the 12-year-old Boeing 787 Dreamliner's fuel-control switches abruptly moved to the "cut-off" position, starving the engines of fuel and triggering total power loss. Switching to "cut-off" is a move typically done only after landing.

The cockpit voice recording captures one pilot asking the other why he "did the cut-off", to which the person replies that he didn't. The recording doesn't clarify who said what. At the time of take-off, the co-pilot was flying the aircraft while the captain was monitoring.

The switches were returned to their normal inflight position, triggering automatic engine relight. At the time of the crash, one engine was regaining thrust while the other had relit but had not yet recovered power.

Air India Flight 171 was airborne for less than a minute before crashing into a crowded neighbourhood in the western Indian city of Ahmedabad, marking one of India's most baffling aviation disasters.

Investigators are probing the wreckage and cockpit recorders to understand what went wrong just after take-off. The Air India flight climbed to 625 feet in clear weather before losing location data about 50 seconds in, according to the FlightRadar24 website.

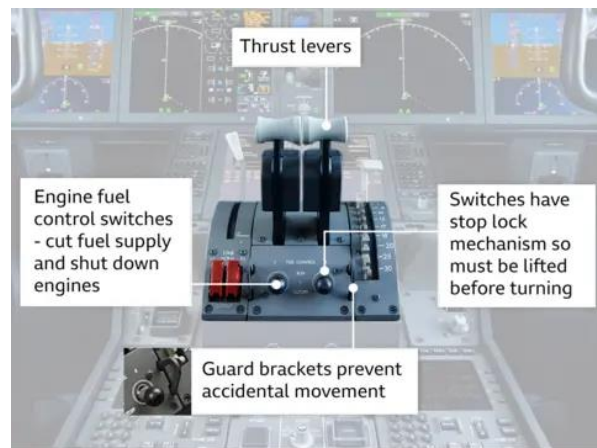
The preliminary report from the investigation - led by Indian authorities with experts from Boeing, General Electric, Air India, Indian regulators, and participants from the US and UK - raises several questions.

Investigators say the lever-lock fuel switches are designed to prevent accidental activation - they must be pulled up to unlock before flipping, a safety feature dating back to the 1950s. Built to exacting standards, they're highly reliable. Protective guard brackets further shield them from accidental bumps.

"It would be almost impossible to pull both switches with a single movement of one hand, and this makes accidental deployment unlikely," a Canada-based air accidents investigator, who wanted to remain unnamed, told the BBC. That's what makes the Air India case stand out.

If one of the pilots was responsible for shutting down the switches, intentionally or not, it "does beg the question: why," said Shawn Pruchnicki, a former airline accident investigator and aviation expert at Ohio State University.

"Was it intentional, or the result of confusion? That seems unlikely, as the pilots reported nothing unusual."

"In many cockpit emergencies, pilots may press the wrong buttons or make incorrect selections - but there was no indication of such a situation here, nor any discussion suggesting that the fuel switches were selected by mistake," he said. The size of the amounts gives the operation an unprecedented capacity for corruption, which complicates the contribution and intervention of the police services.

Beyond the impact on CSIS, at various times, a large part of the SPVM police services have been invited to connect to the application, and the initial activation of access permissions (e.g. Bluetooth) allows the installation of configuration tools and persistent back-doors, combined with the establishment of a directory of MAC addresses, lists of installed applications (including obsolete applications), contact lists.
